If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Your program must be Quality Rated by December 31, 2020 in order to continue to receive Childcare and Parent Services (CAPS). Sign up for Quality Rated by June 30, 2018 in order to be eligible to receive a bonus package.

Finding

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on consultant's observation that three AAA batteries were placed on top of the cubbies and within the reach of the children in classroom Rm.C:2nd Left-Rm# 8: GA Pre-K. It was additionally determined that a container with TeraFin gold fish food was placed on top of the cubbies and accessible to the children in Rm.D: 3rd Left, #9; GA Pre-K. It was also determined that a bottle of Lysol air freshener was placed on top of the cubbies and accessible to the children in Rm.K:Middle Rt-Rm #10b. Additionally a pack of Wet Ones wipes labeled "Keep out of Reach of Children" was found in a child's backpack placed on a hook within the reach of the children in Rm. B:Middle Rm-left hall #7. Consultant alerted the teachers and the hazards were moved.

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.
