#### **Finding**

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on observation that the following hazards were present in building 2 classrooms:

- 2 A- Room F- hydrogen peroxide, shave cream and a spray bottle of bleach and water mixture were on top of the compact size refrigerator.
- 2 A- Room G- hydrogen peroxide was on the counter with the handwashing sink.
- 2B- Room H- sunscreen and bug spray were in a basket on a low shelf and essential oils were on the shelf above children's hooks for bags and coats.

All items had the warning label "Keep out of Reach of Children"

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items. Staff moved all items to to an area inaccessible to children.
