Further, from time to time the department discovers additional rule violations during the course of an investigation. If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- 3) Specific rule number(s) that you are refuting, along with your concerns or questions regarding the rule citation

Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Staffing and Supervision

591-1-1-.32 Supervision(CR)**Not Met****Finding Associated with Complaint**

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs.. It was determined based on consultant's investigation regarding a two-year-old child was left unsupervised in the two-year-old classroom for approximately five minutes while the rest of the class went to the gym was substantiated. Staff statements and interviews the child was left during transition time where the teachers failed to adequately count head-to-roster as required by each staff member. Staff interviews revealed that the child was observed unsupervised by the administrative staff on the center's video camera footage. Consultant reviewed the video footage during the visit and observed child left unsupervised for approximately five minutes. Staff interviews further revealed teachers are required to log children in on the class attendance record to adequately keep track of children during arrival, transition and departure times. Consultant also completed an observation of the center and observed all classrooms to be supervised as required on this date. This allegation was substantiated.

POI (Plan of Improvement)

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times.
