If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. Finding

The annual safety check, completed by a trained individual, should include a check of the: tires, headlights, horn, taillights, turn signals, brake lights, brakes, suspension, exhaust system, steering, windows, windshields and windshield wipers. A copy of the annual safety check will be kept in the Center or on the vehicle and should include evidence of any repairs and/or replacements that were identified as needed on the inspection report. It was determined based observation that the center used the Chief Executive Officer's personal vehicle during a field trip conducted on July 24, 2019. The vehicle did not have an inspection.

POI (Plan of Improvement)

The Center will obtain the annual vehicle inspection.

Finding

591-1-1-.36(4)(f)2. requires that no vehicle shall exceed the manufacturer's rated seating capacity and that proof of the seating capacity is maintained on file. It was determined based on the observation of a field trip checklist to library on July 24, 2019 the center exceeded the vehicle seating capacity in the white van when 14 children were transported in a vehicle that had 13 available seat belts. Based on a staff statement two of the children were buckled into one seat belt.

POI (Plan of Improvement)

The manufacturer's rated seating capacity will not be exceeded and a copy of the manufacturer's seating capacity will be maintained on file at all times.

Before a change of occupant, each mattress shall be cleaned with a disinfectant. It was determined that crib mattresses were torn and covered with electrical tape at the corners leaving the mattresses not waterproof and washable.

POI (Plan of Improvement)

The center will ensure that a crib mattress is firm, tight-fitting without gaps, at least and with tear or holes.
