If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding Associated with Complaint

591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined based on an investigation that a shelf in the two-year-old classroom was hazardous on June 13, 2018, when a two-year-old child sustained a cut to their finger from the sharp edge of an exposed screw where a divider was missing from the shelf. Professional medical attention was required.

POI (Plan of Improvement)

The Center was not aware that a divider had broken off of the shelf, and that the sharp edge of a screw was exposed. The Center will ensure that equipment and furniture in safe repair at all times.
