However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

**Finding Associated with Complaint**

591-1-1-.15(6)(f) requires that hot food shall not be served at a temperature which would cause the children to burn their mouths upon consuming the food. It was determined that on January 4, 2018, at approximately 6:45 p.m., a ten-year-old child sustained an injury to the right forearm when the child was served a cup of hot water for a hot chocolate mixture. The ten-year-old child was allowed to stir the hot chocolate and the cup fell over on the child. Professional medical attention was obtained.

**Staffing and Supervision**

**591-1-1-.32 Supervision(CR)**

**Not Met**

**Finding Associated with Complaint**

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined that on January 4, 2018, at approximately 6:45 p.m., a ten-year-old child was served a cup of hot water to make hot chocolate. The ten-year-old child was allowed to stir the hot chocolate mixture, unsupervised, and the hot chocolate spilled on the child. The staff person went outside and left the ten-year-old child unsupervised with the hot chocolate. Professional medical attention was obtained.
