591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation that on the right playground one to two inches of resilient surface was observed beneath the swings. In addition one to two inches of resilient surface was observed beneath the slides, monkey bars, rock wall, and green ladder of the brown and green climbing structure.

## POI (Plan of Improvement)

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency. Director stated that mulch will be purchased on this date to ensure fall zones have adequate resilient surface.

## Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on observation that on the right and left playground, black tarp was exposed through the ground causing a potential tripping hazard. In addition on the right playground a cable line was observed stretched across the front end of the playground close to the swings causing a potential tripping hazard.

## POI (Plan of Improvement)

The Center will remove any litter and fix or remove hazards from the playground and will routinely monitor the playground and remove litter and hazards. Director stated that mulch will be purchased on this date to ensure fall zones have adequate resilient surface and tripping hazards would be buried.
