Finding

591-1-1-.14(1) requires the Center Director and, at any given time, at least fifty percent (50%) of the caregiver Staff to successfully complete a biennial training program in cardiopulmonary resuscitation (CPR) and a triennial training program in first aid. The first aid training must be done by certified or licensed health care professionals or trainers and must deal with the provision of emergency care to infants and children. The Center shall maintain current evidence of the successful completion of such training which shall be available to the Department for inspection. It was determined, based on review of staff files, that seven staff members hired after October 1, 2016 did not have current evidence of first aid and CPR on file.

POI (Plan of Improvement)

The Center Director will ensure that all new direct care staff obtain first aid and CPR within 90 days of hire. Remaining staff should completed the training by November 2, 2017.

It was determined, based on review of staff files that four staff members did not have current documentation of health and safety orientation on file.
