## Finding

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on observation of consultant that rubbing alcohol and nail polish remover were located in an unlocked cabinet and accessible to children in the Pre-K 1 1L classroom. In addition, bleach, floor cleaner, and three vacuum cleaners were located in an unlocked storage closet and accessible to children in the Pre-K 1L classroom.

### **POI (Plan of Improvement)**

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.
