On this date, the consultant followed up to previous visit and conducted an on-site Complaint Investigation and Monitoring Visit. Consultant requested the provider submit required documents for the Administrative Review process. An Administrative Review was conducted on July 18, 2022. Staff files, children's files, training, and background checks were all reviewed. The Consultant completed exit conference virtually and a copy of the monitoring visit report was electronically emailed to the Program on July 18, 2022.

Please refer to the website, http://www.decal.ga.gov/CCS/RulesAndRegulations.aspx, for information regarding October 1, 2018 rule changes about Criminal Records Checks that may affect your facility. In summary,

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

Finding

591-1-1-.03(9) requires center staff to refrain from engaging in, or allowing children or other adults to engage in, activities that could be detrimental to a child's health or well-being, such as but not limited to, horse play, rough play, wrestling, and picking up a child in a manner that could cause injury. It was determined, based on observation, that the Staff member in the 3rd Right classroom was observed to pick up a child by one arm, holding the child's wrist, to relocate the child from the tile floor near the tables to the carpeted area of the classroom.

POI (Plan of Improvement)

The Center will review requirements with Staff to ensure that appropriate activities are conducted with children.

591-1-1-.12(2) - The Consultant discussed with the Director to please be mindful of the blue vinyl mat on the floor of the 2nd Left classroom, as it was beginning to show small tears in the corners on this date.

Finding

591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined, based on observation, that two adult chairs in the 1st Right classroom were observed to have tears in the fabric with foam exposed, which prevented the chairs from being kept clean on this date.

POI (Plan of Improvement)

The Center will ensure that equipment and furniture are used by the age-appropriate group of children.

591-1-1-.25(11) requires that floor coverings be tight, smooth, free of odors and washable or cleanable. It was determined, based on observation, that the flooring in the Boys' Hallway Bathroom was observed to be uneven and missing vinyl tiles around the toilet in the bigger stall on this date.

POI (Plan of Improvement)

Floors will be maintained to be safe and sanitary.

Finding

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined, based on observation, that the following potential hazards were observed accessible to children on this date:

- •1st Left Classroom Plastic bags were observed accessible in children's cubbies and on top of children's cubbies. A can of Lysol disinfectant spray was observed accessible on top of children's cubbies. A tape dispenser with a serrated edge was observed accessible on a low shelf. A trash bag was observed in the top drawer of storage drawers labeled Teacher Supplies.
- •1st Right Classroom A broom and dustpan were observed accessible near the trash can. Clorox spray was observed accessible on a low shelf. Plastic bags and trash bags were observed accessible in storage drawers near the classroom door to the hallway. A plastic bag, a bottle of hand sanitizer, and a container of Clorox disinfecting wipes were observed accessible to children on the table by the foods being served for breakfast.
 •3rd Right Classroom Plastic bags were observed accessible in an unsecured cabinet under the diaper changing table.
- •Boys' Bathroom in Hallway A toilet brush was observed in an unsecured cabinet under the handwashing sinks. A plunger was observed accessible to children by the toilet in the bigger stall.
- •Girls' Bathroom in Hallway A spray bottle with purple cleaner was observed accessible in an unsecured cabinet under the handwashing sinks.

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

It was determined, based on observation, that children were observed to use hand sanitizer to clean their hands upon arrival to the center and before eating breakfast, when it was required for children to wash their hands with liquid soap and warm running water.

POI (Plan of Improvement)

The Center will train Staff on required handwashing for children and Staff will ensure children's hands are washed when required. The Director will monitor for compliance.

It was determined, based on observation, that upon the Consultant's arrival to the center, all children, from one-year-old children through school aged children, were observed housed in the 1st Right classroom eating breakfast and watching TV on this date. The children were separated into their individual classrooms after breakfast.

The Center will maintain separation of these children under three years old.
