Finding Associated with Complaint

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on staff statements and a review of records obtained during the course of an investigation, that in July 2017 roaches had been observed in the infant and beginners classrooms. Provider had proof of licensed pest control coming out in July 2017 to respond to sighting of roaches. Additionally provider had proof of regular maintanance by licensed pest control at the center. Staff statements also revealed that while licensed pest control had been providing service for roach sightings the beginners classroom had been closed.

POI (Plan of Improvement)

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris is removed. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.
