#### Comments

The purpose of today's visit was to conduct an incident investigation and follow-up from the previous visit conducted on February 27, 2019. The investigation remains open at this time. Once the investigation is completed, the findings will be reviewed with the provider and a final copy will be sent.

The investigative findings were sent to the provider via email on June 10, 2019 and reviewed over the phone.

A revision was made on June 11, 2019 with regards to severity for a core rule citation and revisions were resent to the provider on this date.

#### Advisement of Potential for Repeated Rule Violations during Pending Investigations

This report shall serve as official notice of potential rule violations. These potential rule violations have been detailed in this report and discussed with you by the consultant. The department shall conduct a thorough investigation to determine if in fact the alleged rule violation(s) should or should not be substantiated. Please be aware that the investigation may take some time to be finalized to ensure fairness and accuracy. During this investigation period, any violations of an identical rule or rules will require the department to treat any and all substantiated rule violations identified in the investigation as repeated rule violation(s).

Further, from time to time the department discovers additional rule violations during the course of an investigation. If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
New clearance is required at least once every five years
Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
All staff members are required to have completed at least a national fingerprint based clearance check
Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

# 591-1-1-.12 Equipment & Toys(CR)

# Finding Associated with Complaint

591-1-1.12(1) requires each Employee and child in attendance to use all indoor and outdoor furniture, activity materials, and equipment in a safe and appropriate manner and in accordance with the manufacturer's instructions, recommendations, and intended use. All equipment and furniture shall be used only by the ageappropriate group of children. It was determined that on April 24, 2019, a seesaw located on the center's Playground C was placed on bare ground and is required to be positioned over resilient surfacing with a minimum depth of six inches and a fall zone consisting of six feet. The manufacturer's recommendations on page seven of the installation manual states, "The maximum fall height for the product is 32 in (81 cm)." A three-year-old child was standing on the equipment and fell to the ground injuring his arm.

# POI (Plan of Improvement)

The Center will ensure Staff are trained in and children are taught the proper use of all furniture, materials and equipment; will implement a plan for this information to be reviewed with both groups on an ongoing basis; and for monitoring proper and age-appropriate usage.

## 591-1-1-.32 Supervision(CR)

### **Finding Associated with Complaint**

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined that on April 24, 2019 a three-year-old child sustained an injury requiring medical attention after falling off from a seesaw located on the center's playground. The only staff member supervising children on the playground at the time of the incident was not in the vicinity of the children using the equipment. The staff member did not intervene when children were using the equipment in an inappropriate manner.

# **POI (Plan of Improvement)**

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times.
