Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding Associated with Complaint

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on consultant observation and staff statements that there is currently a leak under the sink in the Junior toddler classroom (3L) which is causing water to seep under the floor, causing a slipping hazard, and the leak also has caused damage to the bottom of the sink area and mold under the sink cabinet. Staff in the classroom is maintaining a safe environment by keeping the floor dry and the cabinet under the sink empty, closed and inaccessible to children. Documentation was provided by the owner / director indicating that the center is aware of the leak and has been in contact with contractors to get the leak fixed as soon as possible. The repairs are planned to be completed during the weekend of January 27, 2018.

POI (Plan of Improvement)

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris is removed. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.
