# 591-1-1-.12 Equipment & Toys(CR)

#### Finding

591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined based on consultant's observation the first left door on the children's stove was broken in the home living area located on the back right side of the room in classroom I-2R.

It was determined based on consultant's observation the exhaust fans in the following classrooms were inoperable on this date: classroom F-3R, classroom J-1R, and G-4L.

#### POI (Plan of Improvement)

The Center will fully enclose and ventilate bathroom areas, as required, and will provide adequate ventilation and sanitation in bathrooms that are not fully enclosed.
