- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- · New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. - -in classroom Gym -PreK: the storage closet was observed to be unlocked, containing cleaning products and a staff bag; one bottle of cleaner was observed stored on a low table; two staff bags were observed on the floor in the back left area of the classroom, accessible to children.
- -in classroom 3rd right three-year-olds : a staff purse was observed to be stored in a low, unlocked cabinet, accessible to children
