Further, from time to time the department discovers additional rule violations during the course of an investigation. If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. 591-1-1-.03 Activities Not Met

Finding Associated with Complaint

591-1-1-.03(9) requires center staff to refrain from engaging in, or allowing children or other adults to engage in, activities that could be detrimental to a child's health or well-being, such as but not limited to, horse play, rough play, wrestling, and picking up a child in a manner that could cause injury. It was determined based on face to face interviews and review of two videos that a staff member had instructed two children to run after a special needs child and bring him to her. Additionally, one child grabbed the five-year-old special needs child by the left arm and brought him back to the teacher. Additionally, a second child knocked the special needs child down by running into him with her stomach. Both children was instructed by the teacher to bring the child to her and allowed to engage in rough play.

POI (Plan of Improvement)

The Center will review requirements with Staff to ensure that appropriate activities are conducted with children.

Finding Associated with Complaint

591-1-1-.29(1) requires that within twenty-four (24) hours or the next work day, the Director or designated person-in-charge shall report or cause to be reported any suspected incidents of child abuse, neglect or deprivation to the local County Department of Family and Children Services in accordance with state law and to the Department, notifying that such a report was made. It was determined based on face-to-face interviews with staff, face to face interviews with children, review of two videos and the center director's statement that she discussed this incident that occurred on July 14, 2021, with her superiors and requested guidance. A decision was made by Human Resources that it was felt the situation did not rise to the severity of abuse and would be taken care of in house as a staff disciplinary action with termination. The incident was not reported to DECAL and DFCS as required.

POI (Plan of Improvement)

The Center will develop a procedure so everyone knows how and when to report incidents of suspected child abuse, neglect or deprivation to the County Department of Family and Children Services and to the Department and will follow-up to make sure they are reported as required.

591-1-1-.11 Discipline(CR)

Not Met

Finding Associated with Complaint

591-1-1-.11(2) requires that Personnel not: physically or sexually abuse a child or engage or permit others to engage in sexually overt conduct in the presence of any child enrolled in the Center; inflict corporal/physical punishment upon a child; shake, jerk, pinch or handle a child roughly; verbally abuse or humiliate a child which includes, but is not limited to, the use of threats, profanity or belittling remarks about a child or his family; isolate a child in a dark room, closet or unsupervised area; use mechanical or physical restraints or devices to discipline children; use medication to discipline or control children's behavior without written medical authorization issued by a licensed professional and given with the parent's written consent; restrict unreasonably a child from going to the bathroom; punish toileting accidents; force-feed a child or withhold feeding a child regularly scheduled meals and/or snacks; force or withhold naps; allow children to discipline or humiliate other children; or confine a child for disciplinary purposes to a swing, highchair, infant carrier, walker or jump seat. It was determined by face-to-face interviews with staff, face to face interviews with children, staff written statements, and two videos that on July 14, 2021, while outside on the playground, a staff member forcefully put her hands on a five-year-old special needs child pushing his head backwards and forcefully snatched the child from the bench of a picnic table. Additionally, the staff member lunged forward over the picnic table towards the child in a threatening manner causing the child to cringe, bend his knees and to lower his body to the picnic table in a way he appeared to be intimidated or afraid. Additionally, the staff member was observed to take this child's cup of water out of his hands and pour it out as well as take the cups of other children and pour their water out as well when water is required during outside play. The temperature outside mid-day on July 14, 2021, was in the mid 80's.

POI (Plan of Improvement)

The Center will take immediate action to ensure the action/conduct has ceased; train/review appropriate child guidance techniques with center staff; and have a system in place to monitor and identify inappropriate actions.
