# Comments

This Monitoring Visit is the first regulatory visit for Little Miracles Daycare this 2019 - 2020 fiscal year. The center currently has a one star Quality Rating. The cook stated that the center currently does not administer medication, no field trips or routine transportation is provided.

Note: The center director will ensure that when changing out the resilient surface she will eliminate the tree bark and replace with sand, rubber mulch, or shaved mulch.

Any rule violation which subjects a child to injury or life-threatening situation or any rule violations previously cited but not corrected, may result in the imposition of an adverse enforcement action. Serious or continued noncompliance may also jeopardize participation in one or more DECAL program(s).

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

# 591-1-1-.12 Equipment & Toys(CR)

**Not Met** 

#### **Finding**

591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. The Consultant observed the following hazards:

- -The building blocks in room C are frayed and the sides are separating.
- -The corner edge of the railroad carpet in room A had exposed frayed edges.
- -The back wall of the diapering table in room D, was pushed in from the top.

The Center will ensure that equipment is made inaccessible to children until they are either replaced or repaired.

**Health and Hygiene** 

#### **Finding**

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on the consultant's observation that the following hazards were observed:

- -On the right side of the playground, there was freyed duck tape located on three of the swings.
- -On the left side of the playground, the red choo choo train is missing 8 out of 20 bolts. The opening to the tunnel, at the back of the train, has a bolt that is hanging 0.5 cm from the top.

# POI (Plan of Improvement)

Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters. The Center will remove, replace, or repair the freyed duck tape on the swings and ensure that all bolts are replaced and tightened on the red choo choo train.

#### **Finding**

591-1-1-.30(4). requires that if cots and mats are stored in the children's activity room or area, they shall be stored to prevent children's access to them and to allow maximum use of play space. When storage is available and used for the storage of cots and mats that allows the cots, mats and any bedding to be stored without touching any other cots, mats or bedding, the bedding may be left on the cot or mat. When such storage is not available for the cots and mats, each child's bedding shall be kept separate from other children's bedding and stored in containers marked for individual use, such as, but not limited to, bins, cubbies, or bags. It was determined, based on the consultant's observation, that the cots are stored with the sheets in room B (infants) and room E (school-age) in the closet. Additionally, there are three mats stacked on top of each other that are stored with cots under a sheet in room C (three and four-year-olds).

#### POI (Plan of Improvement)

The Center will store cots and mats so that each child's bedding is separate from the others.

It was determined based on the consultant's observation and the review of records, that in room D, there were three two-year-olds mixed in with five three-year-olds without a parental agreement in the files of the two-year-olds.

The Center will maintain separation of these children under three years old or obtain parental agreement from the parent's of the two-year-olds.
