# **Finding Associated with Complaint**

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined that inappropriate supervision occurred on December 14, 2017, when one staff member were left to supervise the infant classroom and the one-year-old classroom alone. Also, it was determined, during an investigation that inappropriate supervision occurred on December 4, 2017, when a one-year-old child attempted to climb out of the crib during nap time. It was revealed that no staff member was present inside the classroom at the time the child attempted to climb out of the crib. A staff member sweeping the hallway observed the child and was able to run inside the classroom and catch the child before the child was able to climb completely out of the crib.

#### POI (Plan of Improvement)

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times.
