- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. It was determined based on observation that staff failed to use equipment in accordance with the manufacturer's instructions when an infant was observed unstrapped in a high chair in room A-1L and four children were unstrapped in table bucket seats in room D-4L.

The Center will ensure Staff are trained in and children are taught the proper use of all furniture, materials and equipment; will implement a plan for this information to be reviewed with both groups on an ongoing basis; and for monitoring proper and age-appropriate usage.

It was determined based on observation that an infant was asleep in a bouncy seat in room A-1L.

POI (Plan of Improvement)The Center will only place infants in safe cribs to sleep and will transfer them to a safe crib when the infants are asleep in other equipment.
