#### Comments

Due to COVID-19 Pandemic, no in person visit was completed. An administrative reveiw was completed on 08-23-2021 and a virtual visit was completed on 08-24-2021. Due to COVID-19 both classrooms are temperarily closed and no staff or children were present. The center director was present and completed the walk through virtually. The center director stated no medication is administered, no field trips or routine transportation is provided. The center had a total of 6 staff in which all are vetrin staff. The consultant commended the center director for staff retention.

#### Plan of Improvement: No Plan Developed

(O.C.G.A. Section 20-1A-4)
