O.C.G.A. Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Licensed capacity observed to be routinely met by center. 591-1-1-.25 Physical Plant - Safe Environment(CR)

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on observation that a teacher's bag was accessible in classroom 101 next to the entry door and in classroom 103 next to the children's mats. It was further determined that there was Petroleum Jelly in a child's backpack in classroom B/1R and Desitin and Vaseline Cream in a child's backpack in classroom 103.

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

Finding

591-1-1-.36(4)(b) requires that the interior of a transportation vehicle be clean, in safe repair and free of hazardous items, objects and/or other non-essential items which could cause injury. It was determined based on observation that on bus 118, the driver's seat and six passenger seats had exposed foam. It was further determined that there were two passenger seats arm rests missing on bus 118. It was even further determined that on bus 119, six passenger seats had exposed foam and one passenger seat was missing the arm rest that had an exposed screw.

POI (Plan of Improvement)

The center will replace the missing arm rail and tape up all holes that had exposed foam. The center will maintain that all transportation vehicles are clean, in safe repair, and free from hazards.
