In classroom labeled "1L", employee's purse, scissors and baby lotion labeled "Keep Out Of Reach Of Children" was stored accessible to children in an unlocked cabinet on this date. In classroom labeled "3R", consultant observed "Destin" labeled "Keep Out Of Reach Of Children" stored in an unlocked cabinet under the changing table on this date.

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

591-1-1-.30(4). requires that if cots and mats are stored in the children's activity room or area, they shall be stored to prevent children's access to them and to allow maximum use of play space. When storage is available and used for the storage of cots and mats that allows the cots, mats and any bedding to be stored without touching any other cots, mats or bedding, the bedding may be left on the cot or mat. When such storage is not available for the cots and mats, each child's bedding shall be kept separate from other children's bedding and stored in containers marked for individual use, such as, but not limited to, bins, cubbies, or bags. It was determined based on consultant observation, cots stored with bedding touching the bottom of other cots in classrooms labeled "1L" and "2L" on this date.

## POI (Plan of Improvement)

The Center will store cots and mats so children do not have access to them and they don't take up play space and will store them so each child's bedding is separate from the others.
