However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- 3) Specific rule number(s) that you are refuting, along with your concerns or questions regarding the rule citation

Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.03 Activities**Not Met****Finding Associated with Complaint**

591-1-1-.03(9) requires center staff to refrain from engaging in, or allowing children or other adults to engage in, activities that could be detrimental to a child's health or well-being, such as but not limited to, horse play, rough play, wrestling, and picking up a child in a manner that could cause injury. It was determined based on investigative findings that on the morning of November 8, 2017, the children were transitioning from breakfast to circle time. The children were placed on the carpet for transition time. A child was observed to walk over to the block center and grab a pencil from the center. The child then proceed to walk over to another child and take the pencil and poke the child in the eye before either teacher could respond. The two children were removed from the classroom and the child who was poked in the eye was comforted by center staff and EMS was called to the center. EMS looked at the child's eye ad determined that the child had just a scratch on the eye. Based on investigative findings it was determined that rough play was involved in that the child was poked in the eye with the pencil.

POI (Plan of Improvement)

The Center will review requirements with Staff to ensure that appropriate activities are conducted with children.
