Administrative Review completed on 5/13/2020. Staff files, children's files, training and background checks were all reviewed. A virtual inspection was conducted on 6/11/2020. with the Director. An in-person visit was not conducted due to the COVID-19 pandemic. Compliance with the Executtive Order issues on May 12, 2020 was reviewed during the virtual inspection.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. 591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined, based on observation, that the blue vinyl couch and the light blue vinyl seat used by children in the Middle Classroom in Building One were observed to have tears with foam exposed, which prevented the furniture from being able to be kept clean on this date.

POI (Plan of Improvement)

The Center will ensure that equipment and furniture are used by the age-appropriate group of children. The director removed the blue vinyl couch and the light blue vinyl seat from the classroom during the virtual inspection.

Finding

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation during a virtual visit that the swings in the middle of the playground had less than three inches of resilient surfacing when six inches is required in the fall zones. It was further determined that the slide on the wooden play structure on the left side of the playground did not have resilient surfacing when three inches of resilient surfacing was required.

POI (Plan of Improvement)

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency.
