

#### Finding

Previously Cited: 591-1-1-.26(7) requires that climbing and swinging equipment be anchored and have a resilient surface beneath the equipment. The fall-zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation that on the front play the following had adequate resilient surface:

-Swings set: approximately one to two inches in depth -Red and Blue Slide: approximately one inch

Six inch of resilient surface was needed for both.

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation that the Red and Blue Slide had approximately one to two inches of

resilient surface when six inches was needed.

#### POI (Plan of Improvement)

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency. The consultant left a Fall zone chart.
