#### Advisement of Potential for Repeated Rule Violations during Pending Investigations

This report shall serve as official notice of potential rule violations. These potential rule violations have been detailed in this report and discussed with you by the consultant. The department shall conduct a thorough investigation to determine if in fact the alleged rule violation(s) should or should not be substantiated. Please be aware that the investigation may take some time to be finalized to ensure fairness and accuracy. During this investigation period, any violations of an identical rule or rules will require the department to treat any and all substantiated rule violation(s).

Further, from time to time the department discovers additional rule violations during the course of an investigation. If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. Please see GBI's website located at http://gbi.georgia.gov to access the Georgia Sex Offender Registry.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Includes, but is not limited to, the use of threats, profainty or belitting remarks about a child or his far olate a child in a dark room, closet or unsupervised area; use mechanical or physical restraints or of iscipline children; use medication to discipline or control children's behavior without written medical uthorization issued by a licensed professional and given with the parent's written consent; restrict nreasonably a child from going to the bathroom; punish toileting accidents; force-feed a child or with eeding a child regularly scheduled meals and/or snacks; force or withhold naps; allow children to dis umiliate other children; or confine a child for disciplinary purposes to a swing, highchair, infant carri- r jump seat. It was determined based on investigative findings that on September 7, 2018, Septemb 018, and September 11, 2018, a staff member in the "Bridge" classroom used inappropriate disciplin ractices. Video footage on September 7, 2018 was observed to show three-year-old children being the arm during two different incidents. The staff member was also observed to push a three-year-old he floor and shove a three-year-old by the back of the head. Further, the staff member was observe heir feet to move a child out of the way and used intimidation with the use of a pointer stick towards our times. Video footage from September 10, 2018 was observed to show three-year-old children be rabbed by the arm during two different incidents. The lead teacher was also observed to kick a child ack while the child was sitting in circle time with other children.
