### **Finding Associated with Complaint**

591-1-1-.36(4)(f)1. requires that all transported children be secured in a child passenger restraining system or seat safety belt in accordance with current state and federal laws and regulations and according to manufacturer's directions. It was determined based on a complaint investigation that on May 4, 2018 the seat belts on the vehicle were not in good repair on vehicle PVW 2030.

### **POI** (Plan of Improvement)

The Center will ensure that manufacturer directions and state and federal laws are met when using child passenger restraining systems and seat safety belts.
