- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. Children older than four (4) years of age may be served these foods provided that the foods are cut in such a way as to minimize choking.

Please ensure the new updated infant feeding form is used. Discussed revision to the written feeding plans for children under the age of 1 years old. Age-appropriate solid foods (including cereal) shall not be given to infants or children less than one (1) year of age until recommended as developmentally appropriate by the child's primary care physician and indicated in writing by the Parent(s). As soon as the feeding plan indicates that a child is ready for solid foods, the child shall be fed from individual spoons and individual containers or dishes. A child shall not be fed directly from the original baby food container if the contents are to be fed to the child at more than one (1) meal or to more than one (1) child.

The Comprehensive Records Check Determination must have a Records Check Clearance Date that is no older than the preceding 12 months of the hire date; provided, however, if the Employee has had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, a new satisfactory Comprehensive Records Check Determination is required. It was determined based on Consultant's review of staff records that a staff member hired on September 21, 2020 did not have valid evidence of a satisfactory comprehensive background check determination letter on this date. It was determined based on review of staff records that the staff member was present in the child care facility from March 20, 2020 until June 1, 2021 when the department issued a satisfactory clearance letter. It was determined the staff member was present and supervised with a staff member that has a comprehensive background determination letter.

#### POI (Plan of Improvement)

IMMEDIATE CORRECTION - The Center will maintain a staff spreadsheet to ensure that every Employee has a valid and current satisfactory Comprehensive Records Check Determination on file prior to being present at the Center while any child is present for care or before an individual age 17 or older resides in the Center. The Comprehensive Records Check Determination must have a Records Check Clearance Date that is no older than the preceding 12 months of the hire date; provided, however, if the Employee has had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, a new satisfactory Comprehensive Records Check Determination is required. The program's owner or an officer/member of the corporation must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The center will create a document with expiration dates to ensure the CRC rules are maintained.

It was determined based on Consultant's review of staff records that a staff member hired on September 21, 2020 did not have valid evidence of a satisfactory comprehensive background check determination letter on this date. It was determined based on review of staff records that the staff member was present in the child care facility from March 20, 2020 until June1, 2021 when the department issued a satisfactory clearance letter. It was determined the staff member was present and supervised with a staff member that has a comprehensive background determination letter. It was determined the Director was not aware of the expired application until contacting the department and had to resubmit out-of-state documents to the department.

IMMÈDIATE CORRECTION - The Center will monitor and maintain documents of new and current employees to ensure that each Director, Employee and Provisional Employee has a Comprehensive Records Check Determination on file that has been issued within the past five years. The program's owner or an officer/member of the corporation must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The Center will document expiration dates and send periodically check the status to ensure CRC rules are maintained.
