#### Advisement of Potential for Repeated Rule Violations during Pending Investigations

If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. # **Activities and Equipment**

591-1-1-.03 Activities Not Met

#### **Finding Associated with Complaint**

591-1-1-.03(9) requires center staff to refrain from engaging in, or allowing children or other adults to engage in, activities that could be detrimental to a child's health or well-being, such as but not limited to, horse play, rough play, wrestling, and picking up a child in a manner that could cause injury. It was determined that on April 12, 2019, a seven-month-old infant sustained a right leg injury as a result of the staff member pulling on the child's right leg. The infant received professional medical attention. Additionally, video footage from the morning of April 8, 2019 revealed staff members rough handling children in the infant room. Staff were observed picking infants up roughly by their upper arms to move them. A staff person reached from a sitting position on the floor and grabbed an infant by the arm and slide the child to her. A staff person picked an infant up roughly and put him face down on a boppy pillow. The infant attempted to roll over and the staff went to the child, flipped the child over and pulled him by the legs. Two infants were observed to crawl over to two separate staff persons and one staff pushed the infant away and the other staff grabbed the infant roughly to move the child away from her.

#### POI (Plan of Improvement)

The Center will review requirements with Staff to ensure that appropriate activities are conducted with children.

**Food Service** 

**Not Met** 

#### **Finding Associated with Complaint**

591-1-1-.15(2)(a) requires Center Personnel to hold and feed infants less than six months of age and older children who cannot hold their own bottles or sit alone. Baby bottles shall never be propped; the infant's head shall be elevated while feeding. It was determined based on investigative findings that staff members were observed propping infant bottles. Additionally, staff were observed to hold bottles to feed infants while the infants were reclined in equipment and the infant's heads were not elevated. Additionally, on April 12, 2019, at approximately 12:06 pm., a staff member was observed propping an infant's bottle while the infant was lying in an infant rocker.

#### POI (Plan of Improvement)

The Center will train Staff to hold infants less than six months old or who can not hold their own bottle, to never prop bottles and to elevate infant's heads during feeding. The director will monitor Staff to ensure appropriate feeding procedures are followed.

## **Finding Associated with Complaint**

591-1-1-.17(8) requires staff to wash their hands with liquid soap and warm running water upon arrival for the day, when moving from one child care group to another, upon re-entering the child care area after outside play, before and after diapering each child, dispensing medication, applying topical medications, handling and preparing food, eating, drinking, preparing bottles, feeding each child, assisting children with eating and drinking, after toileting or assisting children with toileting, using tobacco products, handling garbage and organic waste, touching animals or pets, handling bodily fluids and after contamination by any means. It was determined based on investigative findings that a staff member failed to wash their hands before and after diapering each child.

#### POI (Plan of Improvement)

The Center will ensure liquid soap and warm running water are available for handwashing, train Staff on the handwashing requirements, review the requirements with Staff periodically, and monitor handwashing.

# **Sleeping & Resting Equipment**

#### 591-1-1-.30 Safe Sleeping and Resting Requirements(CR)

**Not Met** 

#### **Finding Associated with Complaint**

591-1-1-.30(2)(c) requires that infants shall not sleep in equipment other than safety-approved cribs, such as, but not limited to, a car safety seat, bouncy seat, highchair, or swing. Infants who arrive at the Center asleep or fall asleep in such equipment, on the floor or elsewhere, shall be transferred to a safety-approved crib. It was determined based on video footage on April 8, 2019 and April 12, 2019 infants were observed sleeping in infant swings, infant nappers and on boppy pillows and were not placed in cribs to nap.

#### **POI** (Plan of Improvement)

The Center will only place infants in safe cribs to sleep and will transfer them to a safe crib when the infants are asleep in other equipment.

**Staffing and Supervision** 

**Not Met** 

#### **Finding Associated with Complaint**

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined based on video footage that on April 12, 2019 at 4:10 pm a parent entered the infant classroom and the staff person began a conversation with the parent. During this time an infant that was placed in an infant swing began twisting and squirming. At 4:18 pm the infant fell forward out of the infant swing onto the head.

# POI (Plan of Improvement)

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times.
