Comments

This Licensing Study is the second regulatory visit for Kidz Express this 2019 - 2020 fiscal year. The center director stated no medication has been administered since the consultant's last visit, no field trips or routine transportation is provided. The center director stated no new staff has been hired since the consultant's last visit. The consultant reviewed all staff files and finds that each staff member has a satisfactory comprehensive fingerprint criminal records clearance determination letter on file.

Plan of Improvement: Developed This Date

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. Finding

591-1-1-.08(1) requires the Center Staff to maintain a file for each child while such child is in care and for one year after that child is no longer enrolled. In order for the file to be complete, the file shall contain the following: child's name, birth date, sex, address, living arrangement, name of school if applicable; names of both Parents, home and work addresses, and home and work telephone numbers; name(s) and addresses of the person(s) to whom the child may be released including address, telephone numbers, relationship to child and to Parent(s), and other identifying information; name(s) and telephone number(s) of person(s) to contact in emergencies when the Parent cannot be reached; name and telephone number of the child's primary source of health care; and a statement regarding known allergies, physical problems, mental health disorders, mental retardation or developmental disabilities which limit the child's participation in the program. It was determined based on observation and review of random child files that one of seven files had not completed the allergy section.

POI (Plan of Improvement)

Center staff will develop a plan that includes how to obtain all required information for currently enrolled children and how to ensure this is done for future enrollees as well. The plan will also include how and where to maintain files for the required amount of time. The plan will be implemented and followed.

Finding

591-1-1-.08(1)(b) requires Center Staff to maintain a file for each child that includes parental authorizations, including, but not limited to, written authorization for the Center to obtain emergency medical care for the child when the Parent is not available. It was determined based on observation and review of random child files that three of seven child files did not have a signed parental authorization acknowledging the center does not provide liability insurance.

POI (Plan of Improvement)

The Center will develop and follow a system to place and maintain all types of parental authorizations in these files.

Finding

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on observation that a hole the size of a door knob was located behind the entry door to the three and four-year-old classroom and accessible to the children, posing a potential entrapment hazard. Additionally, the wheel chair ramp is weathered and in need of cleaning. Additionally, the plastic wire running along the hand rails to the wheel chair ramp is lose and not tight fitting. Additionally, two of three air vents located on the bottom of the house within the child playground on the left sife of the building is busted, accessible to the children and poses and entrapment hazard.

POI (Plan of Improvement)

The Center will have the Center will repair or replace any hazardous items.

Finding

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on observation and measurements that the following hazards was present:

Playground on the left:

- ---A grey Little Tykes Castle has a one and a half inch by three inch crack and a one in crack, accessible to the children and posing a pinching hazard.
- ---One screw and one bolt was protruding on a red, green, grey and blue Little Tykes gym set, accessible to the children posing a potential hazard.

Playground on the right:

---A seven inch crack was observed on the climbing steps of the green and beige climber with the blue slide posing as a potential cutting or pinching hazard.
