If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

**591-1-1-.32 Supervision(CR)****Not Met****Finding Associated with Complaint**

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined based on Consultant's investigation regarding an incident self-reported that on February 16, 2018 a eight-year-old male child inappropriately touched a six-year-old male child in the restroom and staff members were unaware of the incident was substantiated. Staff statements and interviews revealed that children enrolled in the after school program are not supervised during restroom times. Staff interviews revealed that staff was made aware of the incident by the YMCA Director after returning to school on Tuesday, February 20, 2018. Consultant observed children going to and from the restroom during the visit without a staff member supervising. This allegation was substantiated.

**POI (Plan of Improvement)**

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times.
