

Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. Consultant discussed that games in Room B need to be age appropriate. Some of the games were rated "T" for teens, so if they are being used they need to be used for only children that are teens.

It was determined based on consultant observation that a two-year-old child was placed in a highchair in the infant room without any safety straps. It was further determined that the two highchairs in the classroom did not have any safety straps.

591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined based on consultant observation that the following items were in need of repair:

-the top of the little tikes house on the playground had cracks in the roof with sharp edges.

-the bear swing on the swing set had cracks in the right side with sharp edges.

-the large metal teether tooter was missing one of two seats.

-the teether tooter attached to the swing had a crack on the back of the seat. -the plastic toys on the playground were in need of being cleaned due to having sand and black stains on them.

Finding

591-1-1-.08(1) requires the Center Staff to maintain a file for each child while such child is in care and for one year after that child is no longer enrolled. In order for the file to be complete, the file shall contain the following: child's name, birth date, sex, address, living arrangement, name of school if applicable; names of both Parents, home and work addresses, and home and work telephone numbers; name(s) and addresses of the person(s) to whom the child may be released including address, telephone numbers, relationship to child and to Parent(s), and other identifying information; name(s) and telephone number of the child's primary source of health care; and a statement regarding known allergies, physical problems, mental health disorders, mental retardation or developmental disabilities which limit the child's participation in the program. It was determined based on a review of records that two of five records did not have the work address of the release person for the child. It was further determined that one of five records did not have the work address listed for the parent.

Finding

591-1-1-.25(12) requires heating and cooling equipment to be protected to prevent children from touching it. Fans, space heaters, etc. shall be positioned or installed so as to be inaccessible to the children. It was determined based on consultant observation that a fan was placed on top of a shelf in the infant classroom and was installed with the cord hanging down where children within the classroom could pull the cord and the fan could pose a falling hazard.

Finding

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on consultant observation that the following items in the child care center were in need of repair:

-the ceiling of the girls restroom in the infant class was chipping paint.

-the top of the wooden counter beside the refrigerator in the kitchen area was chipping paint.

-the sides of the tiles on the kitchen counter were cracked.

-the door leading into Classroom B from the hallway was cracked at the bottom and missing a large piece of wood.

-dead roaches in the restroom of Classroom B were present near the white storage cabinet.

Finding

591-1-1-.25(8) requires protective caps on all unused electrical outlets within children's reach and requires that electrical outlets in use be made inaccessible to children. It was determined based on consultant observation that several outlets were not covered as required in the classrooms and restrooms of the center.

Technical Assistance

Consultant discussed that hazards need to be kept inaccessible to children in care. In Room B Meyers Cleaner was placed on a shelf, and in the restroom off Room B all purpose cleaner and Axe body wash was in a white cabinet. No children were present in the classroom at the time of the visit.

Finding

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on consultant observation that resilient surfacing was not adequately maintained on the center playground around the blue metal equipment, the blue and yellow metal equipment and swings in that grass was growing through the sand.

591-1-17(7) requires that children wash their hands with liquid soap and warm running water upon arrival for care, when moving from one child care group to another, upon re-entering the child care area after outside play, before and after eating meals and snacks, handling or touching food, playing in water; after toileting and diapering, playing in sand, touching animals or pets, and contact with bodily fluids and after contamination by any other means. It was determined based on consultant observation that upon arrival to the center two enrolled children were not required to wash their hands.

Finding

591-1-1-.21(3) requires that the Center conduct drills for fire, tornado and other emergency situations. The fire drills will be conducted monthly and tornado and other emergency situation drills will be conducted every six months. The Center shall maintain documentation of the dates and times of these drills for two years. It was determined based on a review of records that that center conducted a tornado drill in January 2018, and no other tornado drill has been conducted. It was further determined that the center has not completed the other emergency situation drills every six months as required in that they have no records of them being completed for the 2018 year.

The annual safety check, completed by a trained individual, should include a check of the: tires, headlights, horn, taillights, turn signals, brake lights, brakes, suspension, exhaust system, steering, windows, windshields and windshield wipers. A copy of the annual safety check will be kept in the Center or on the vehicle and should include evidence of any repairs and/or replacements that were identified as needed on the inspection report. It was determined based on consultant review of records that the center van ending in tag number 6037 had an expired annual safety check that expired on May 16, 2017.

Consultant discussed crib sheets and the cleaning of them on this date.

Finding

591-1-1-.30(1)(d) requires that all sleeping and resting equipment shall be arranged to avoid obstructing access to exit doors, to provide the caregivers access to each child, and to prevent children's access to cords hanging from window treatments and other hazardous objects. To reduce the transfer of airborne diseases, sleeping and resting equipment shall be arranged as follows. There shall be a minimum of twenty-four inch (24") corridor between each row of sleeping or resting equipment. There shall be a minimum of twelve inches (12") between each piece of sleeping or resting equipment in each row of equipment. Children shall be placed on cots and mats so that one child's head is toward another child's feet in the same row. It was determined based on consultant observation that cribs in the infant classroom (Room A) were not spaced according to the rules in that they were spaced approximately two inches apart.

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined based on consultant observation that while consultant was in the infant classroom (Room A) one staff member was present with one child and a staff member was knocking on the door to enter the center. The staff left the one child in the classroom and went to answer the door and had a brief break in watchful oversight. It was further determined, that a staff member was present in the infant room (Room A) and left the classroom for a brief moment to step into the kitchen area and answer the phone.
