- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. ## 591-1-1-.09 Criminal Records and Comprehensive Background Checks(CR)

## **Finding**

591-1-1-.09(1)(a) requires that a Center ensure that every actual and potential Director, Employee and Provisional Employee of a Child Care Learning Center submit both a Records Check Application to the Department and Fingerprints to an authorized fingerprinting site. It was determined based on observation of staff criminal records information Koala Outback that a staff #5 had not submitted a new application to the Department nor fingerprinted at an authorized fingerprinting site. The letter on file for the staff persons showed the staff persons last fingerprinted in 2016. The staff person was hire at this program in January 2021.

#### POI (Plan of Improvement)

IMMÉDIATE CORRECTION - The Center will review criminal records information on Decal Koala to ensure at the time of hire and ensure every actual and potential Director, Employee and Provisional Employee of a Child Care Learning Center submit both a Records Check Application to the Department and Fingerprints to an authorized fingerprinting site as required prior to the individual being on site while children in care. The program's owner or an officer/member of the corporation must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The Center will regularly review the rules to ensure the CRC rules are maintained.

### **Finding**

591-1-1-.09(1)(c) requires the Center to ensure that every Employee has a valid and current satisfactory Comprehensive Records Check Determination on file prior to being present at the Center while any child is present for care or before an individual age 17 or older resides in the Center. The Comprehensive Records Check Determination must have a Records Check Clearance Date that is no older than the preceding 12 months of the hire date; provided, however, if the Employee has had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, a new satisfactory Comprehensive Records Check Determination is required. It was determined based on the observation of staff criminal records check information in Koala Outback that staff # 5 had a criminal records check clearance older than the preceding twelve months of the hire date. The clearance letter on file for the staff person was from 2016, and was no longer portable. The staff person was hired at the center in January 2021 with a determination that was no longer valid.

## POI (Plan of Improvement)

IMMEDIATE CORRECTION - The Center will electronically port and review criminal record letters to ensure that every Employee has a valid and current satisfactory Comprehensive Records Check Determination on file prior to being present at the Center while any child is present for care or before an individual age 17 or older resides in the Center. The Comprehensive Records Check Determination must have a Records Check Clearance Date that is no older than the preceding 12 months of the hire date; provided, however, if the Employee has had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, a new satisfactory Comprehensive Records Check Determination is required. The program's owner or an officer/member of the corporation must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The center will review the rules regularly to ensure the CRC rules are maintained.
