### **Finding Associated with Complaint**

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined that staff failed to provide proper supervision on February 8, 2018, when a sixteen month old child left the classroom and ran down the hallway of the center. Another teacher saw the child and took the child to the Director.

## POI (Plan of Improvement)

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times. The staff member was terminated. The Director has provided additional training on supervision for the staff. Staff signed a memo regarding proper supervision.
