Finding

Classroom 1st Left: teacher's lotion and fish food

Classroom 1st Right: mirror on hand washing area needs to be mounted or secure

Classroom 2nd Left: broom

Classroom 3rd Left: unlocked cabinet with diapers in plastic wrapping and wipes

Classroom 4th Left: latex gloves

Classroom 4th Right: diaper rash paste, latex gloves, and plastic bags in an unlocked drawer

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

Finding

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on an observation that Playground A had resilient surfacing measuring zero inches to two inches when six inches is required, Playground B had resilient surfacing measuring zero inches to two inches when six inches is required, and Playground C had zero inches to two inches when six inches in required. It was further determined that weeds were observed growing through the mulch on all playgrounds.

POI (Plan of Improvement)

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency.
