591-1-1-.03(9) requires center staff to refrain from engaging in, or allowing children or other adults to engage in, activities that could be detrimental to a child's health or well-being, such as but not limited to, horse play, rough play, wrestling, and picking up a child in a manner that could cause injury. It was determined that on April 10, 2018 a staff member grabbed a child's hand in such a manner that caused an elbow injury which required medical attention.
