- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance

Finding Associated with Complaint

591-1-1-.17(5) requires that drinking fountains are safe, kept clean, have regulated pressure, not be mounted on sinks used for diaper changing, and have an angle jet with an orifice guard above the rim. Single-service drinking cups shall be provided when appropriate drinking fountains are not available, and cups shall be discarded after each use unless the cups are sanitized in a dishwasher between each use. It was determined based on an investigation that a sippy cup in the two-year-old classroom, was found to not be cleaned or sanitized in a dishwasher between use.

POI (Plan of Improvement)

The Center will check drinking fountains regularly to ensure they meet the requirements. When drinking fountains are not available, the Center will provide single-service drinking cups and throw them away after each use or use cups that are sanitized in a dishwasher between each use.
