591-1-1-.08(1) requires the Center Staff to maintain a file for each child while such child is in care and for one year after that child is no longer enrolled. In order for the file to be complete, the file shall contain the following: child's name, birth date, sex, address, living arrangement, name of school if applicable; names of both Parents, home and work addresses, and home and work telephone numbers; name(s) and addresses of the person(s) to whom the child may be released including address, telephone numbers, relationship to child and to Parent(s), and other identifying information; name(s) and telephone number(s) of person(s) to contact in emergencies when the Parent cannot be reached; name and telephone number of the child's primary source of health care; and a statement regarding known allergies, physical problems, mental health disorders, mental retardation or developmental disabilities which limit the child's participation in the program. It was determined based on a review of five children's files that one of five files was incomplete. The following information was missing:

- 1 of 5 files was missing the complete information for the child's physician.

- 1 of 5 files was missing information regarding the child's allergies.

Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation that on the back left playground at the back fence, the fencing was detached leaving a five to six inch gap.

591-1-1-.26(7) requires that climbing and swinging equipment be anchored. It was determined based on observation that on the left back playground the red and yellow car structure had a torn tire.

It was determined based on observation that the monkey bars and the slide structure had zero inches of measurable resilient surface.
