591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on consultant's observation, that gaps measuring four (4) inches between the fence poles were present through out the exterior fencing around playgrounds A, B, C and the Water park, when they are required to be less than three and one half (3-1/2) inches.

The Center will add a privacy mess around the exterior of the playgrounds to enclose the gaps.
