- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. 591-1-1-.25(11) requires that floor coverings be tight, smooth, free of odors and washable or cleanable. It was determined based on consultant's observation that the floor in the back of classroom D-1R had cracks and tears in it

POI (Plan of Improvement)

The provider is in the process of re-doing the floor in the whole building and will install laminate flooring.

591-1-1-.25(17) - Please ensure that plants and vines growing on the playground or on the fence are removed as needed.

Correction Deadline: 1/4/2019

Finding

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on consultant's observations that repairs were needed as followed:

- -Classroom A-Front- one of four light covers were missing.
- -Classroom D-1R- two of six lights were missing covers and there were cracks and peeling paint on the ceiling in the back of the room.
 - Bathroom for the three and four year olds -protruding rusting bolts at the base of the toilet.

POI (Plan of Improvement)

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.

Discussed maintenance of resilient surface. Please fluff and redistribute.

Technical Assistance

Please ensure that the wooden board around the infant play area has no protruding bolts and is painted in bright colors to prevent the children from tripping on it, or is removed from the play area.

Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on consultant's observation and measurements that there was a four inch gap on the left back corner of the fence. It was also determined that there was a four inch gap at the bottom of the back fence gate. Additionally, it was determined that the gaps between the rails on the stairs leading to the playground measured at four inches when no more than three and a half inch gaps are allowed.

POI (Plan of Improvement)

The Center will routinely check the fence to determine if it is in good repair and will cover the gaps on the railing with mesh.

Findina

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on consultant's observations and measurements, that there was an exposed piece of concrete at the base of the yellow slide on the playground

POI (Plan of Improvement)

The Center will remove the concrete piece and ensure that there is six inches of resilient surface around the slide equipment. The center will not allow the children to use the equipment until the repairs are made.
