- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Trees located on the site or that encroach onto the site from adjacent properties may have structural issues that present an elevated level of risk. Consider having these trees inspected by a certified arborist to determine their structural integrity and associated levels of risk.

Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation and measurements, that the fence on the left side of the playground measured at approximately three feet and four inches, when at least four feet of approved fence is required. Additionally, it was determined that the fence on the front of the playground was three feet, and there were gaps that measured at four inches, when no more than three and a half inches are allowed.

POI (Plan of Improvement)

The provider will ensure that the fence is at least four feet in height, and of approved material. Additionally, the provider will add a gate and fence on the right side of the building that is at least four feet high.
