Certificate of Occupancy was received on July 27, 2020. Permanent License and Permission to Operate issued same day.

- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

You have received permission to operate and the form received with this report is intended to serve as a temporary license which is <u>valid for thirty(30) days</u>. It was determined based on observation that there was a wooden step platform in the fall zone under the climbing ladder on the yellow slide located on Playground B.

The Center will remove the platform and make sure that the fall zone is free of obstructions.
