- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance

### Staffing and Supervision

#### 591-1-1-.32 Staff:Child Ratios and Group Size(CR)

#### **Finding Associated with Complaint**

591-1-1-:32(1) requires the Center to maintain the required Staff:child ratios as follows: under 1 year or under 18 months if not walking = 1:6; 1 year and walking = 1:8; 2 years = 1:10; 3 years = 1:15; 4 years = 1:18; 5 years = 1:20; and 6 years and older = 1:25. A Center must establish groupings of children for care with maximum group sizes as follows: under 1 year = 12; under 18 months/not walking = 12; 1 year and walking = 16; 2 years = 20; 3 years = 30; 4 years = 36; 5 years = 40; and 6 years and older = 50. It was determined based on investigative findings that on May 11, 2022, and a review of records revealed that the following classrooms did not maintain the required staff:child ratios:

- Classroom Two-A Between 12:39 p.m. and 1:09 p.m., a ratio of 1:22 two-year-old children were present when a ratio of 2:22 was required.
- Classroom Two-B Between 11:58 a.m. and 1:02 p.m. and 1:07 p.m. and 2:30 p.m., a ratio of 1:22 two-year-old (11) and three-year-old children (10) when a ratio of 2:22 was required.
- Classroom Two-C Between 1:06 p.m. and 2:04 p.m. a ratio of 1:12 two-year-old (seven) and three-year-old (five) when a ratio of 2:12 was required.

#### **POI** (Plan of Improvement)

The Center will hire additional Staff or reschedule current Staff to meet required Staff:child ratios and will organize children into groups that meet requirements.

#### **Finding Associated with Complaint**

591-1-1-.32(5) requires that during day-time rest or sleeping periods, at least one Staff person is in each room providing direct supervision of the children and all Staff required by these rules relating to Staff: child ratios are in the Center and available to assure safe evacuation in an emergency. Staff: child ratios may be doubled for children three (3) years and older provided these requirements are met. It was determined based on investigative findings that on May 11, 2022, and a review of records revealed that the following classrooms doubled their nap time ratios for children under the age of three-year-old:

- Classroom Two-A Between 12:39 p.m. and 1:09 p.m., a ratio of 1:22 two-year-old children were present when a ratio of 2:22 was required.
- Classroom Two-B Between 11:58 a.m. and 1:02 p.m. and 1:07 p.m. and 2:30 p.m., a ratio of 1:22 two-year-old (11) and three-year-old children (10) when a ratio of 2:22 was required.
- Classroom Two-C Between 1:06 p.m. and 2:04 p.m. a ratio of 1:12 two-year-old (seven) and three-year-old (five) when a ratio of 2:12 was required.

**POI (Plan of Improvement)**The Center will rearrange staff schedules to ensure the required number of staff are in each room and available.
