Permission to operate was granted this date. A virtual licensing visit was conducted with the director, Chadrika Johnson. This was a follow up to the 7/2/20 initial licensing visit. Compliance with the Executive Order issued on June 15, 2020 was reviewed during the inspection and discussed during the exit conference. The program did not have liability insurance and had the required posting.
