The compliance with the Executive Order issued on June 15, 2020 was reviewed during the inspection and discussed during the exit conference on December 23, 2020.

The provider carries liability insurance. The consultant observed the notice posted during the virtual visit on this date.

Finding

591-1-1.06(4) Requires a Center first licensed after March 1, 1991, and Centers that remodel or add to existing plumbing facilities, to have the bathroom area fully enclosed and ventilated to the outside of the building with either an open screened window or functioning exhaust fan and duct system and requires Centers without fully enclosed bathrooms to ensure there is adequate ventilation to control odors and adequate sanitation measures to prevent the spread of contagious diseases. It was determined based on the consultant's observation, the ventilation in the bathroom located near the multi purpose room did not have working ventilation. The center will ensure that all bathrooms have working ventilation.

POI (Plan of Improvement)

The Center will fully enclose and ventilate bathroom areas, as required, and will provide adequate ventilation and sanitation in bathrooms that are not fully enclosed.

591-1-1-.14(1) Requires the Center Director and, at any given time, at least fifty percent (50%) of the caregiver Staff to successfully complete a biennial training program in cardiopulmonary resuscitation (CPR) and a triennial training program in first aid. The first aid training must be done by certified or licensed health care professionals or trainers and must deal with the provision of emergency care to infants and children. The Center shall maintain current evidence of the successful completion of such training which shall be available to the Department for inspection. It was determined based on the consultant's review that the center director did not have a valid biennial training program in cardiopulmonary resuscitation (CPR) and a triennial training program in first aid.
