An in person Initial Licensing Study was conducted on March 17, 2021. The exit conference was conducted virtually on March 18, 2021 at 3:30pm with the Director. Compliance with the Executive Order issued on February 15, 2021 was reviewed during the inspection and discussed during the exit conference. A Temporary Licensed was issued on this date. Pending Zoning, Fire Inspeciton, Certificate of Occupancy, and proof of Water/Sewer services. Facility does carry Liability Insurance.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on observation that the brown closets in classroom C were unlocked with cleaning supplies such as bleach and Clorox wipes accessible to children.

POI (Plan of Improvement)

The Center remove all hazardous items from the closet until it can be locked.

Finding

591-1-1-.26(5) requires that the playground have a surface suitable for varied activities. Hard surfaces (gravel, concrete, paving) shall not exceed one-fourth of the total area. It was determined that the overall hard surface of the playground measures 2975 square feet. The playground surface measured 7172 square feet and allows for 1793 square feet of hard surface.

POI (Plan of Improvement)

The Center will increase the unpaved area or decrease the size of the hard surface to be in compliance.

Finding

591-1-1-.10(1) requires Centers first licensed after March 1, 1991, and Centers that are renovated after March 1, 1991, to provide ventilation in the diapering areas with functioning exhaust fans and a duct system or by the required amount of window space provided by operable windows when open. It was determined based on observation that the windows in classrooms B and C were not being opened during diapering times.

POI (Plan of Improvement)

The Center staff will open windows prior and during all diaper changes in classrooms B and C.
