- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance

# **Activities and Equipment**

591-1-1-.03 Activities Not Met

### **Finding Associated with Complaint**

591-1-1-.03(9) requires center staff to refrain from engaging in, or allowing children or other adults to engage in, activities that could be detrimental to a child's health or well-being, such as but not limited to, horse play, rough play, wrestling, and picking up a child in a manner that could cause injury. It was determined based on investigative findings that a staff member inappropriately handled a two-year-old child in a manner which could have caused them harm when a staff member picked the child up under their arms and threw the child down on their mate while in the two-year-old classroom. Further review of video footage revealed that a staff member further rough handled approximately four other children in a manner which could have caused them harm.

### **POI** (Plan of Improvement)

Upon being notified of the incident on November 5, 2020, the center immediately addressed the parent's concerns, completed an internal investigation (i.e. reviewing video footage and meeting with staff member) and terminated the staff member effective November 5, 2020. The center also self-reported the incident to the department via DECAL KOALA on November 6, 2020 and to the Department of Family and Children Services during the week of November 16, 2020. The center also met with staff members during the week of November 16, 2020 to review the center's policy and procedures regarding appropriately and inappropriately handling of children.
