

-an accumulation of sticky gumball seeds were observed on the ground.

-the grass was overgrown and needed to be cut.

-several discarded screws was observed on the deck accessible to the children,

-a broken piece of a rusted metal pot was observed in the ground in front of the tree in the back right corner of the play area.
