290-2-3-.07(17) requires at least one Staff person with a satisfactory Comprehensive Records Check Determination shall supervise Children at all times and requires plans shall be made to obtain additional Staff help in cases of emergencies. It was determined based on observation that the provider walked out of the house to the mail box and left 1 two-year-old strapped in a high chair, in the dining room, eating lunch with no adult supervision for two minutes. Additionally, 1 six-month-old, 1 ten-month-old, 1 one-year-old, 1 two-yearold and 1 four-year-old was left in the child activity room with no adult supervision for two minutes.

POI (Plan of Improvement)

The Home will ensure that either the Provider or at least one Staff person with a satisfactory Comprehensive Records Check Determination supervises the children at all times. The Home will develop or update a plan to obtain additional Staff help in case of an emergency.
