- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

**Finding**

290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. It was determined based on the consultant's observation and pictures taken that the following hazards are present on the child playground and accessible to the children:

\*\*\*One red Radio Flyer had a broke back fender leaving sharp jagged edges causing a potential cutting hazard.

\*\*\*One green and yellow camper had a three inch crack on the back bumper causing a potential pinching hazard.

\*\*\*The red craw through tunnel located on the red, yellow, green and blue Little Tikes gym set has eight cracks ranging from one half of an inch to seven inches in length causing a potential pinching hazard.

\*\*\*One red coupe Little Tikes car had a missing gas cap leaving a hole the size of a quarter causing a potential pinching hazard.

The Home will repair any and all identified outdoor hazards and will monitor playground daily or more often as needed to ensure that the Home's outdoor play area is kept clean and free of hazards.
